Terms & Conditions

1. Payment for livery is due on the 1st of the month or weekly in advance. Monthly must be paid within 7 days. Weekly within 3 days of been due. A monthly payment straight to A&L act no 03585891 sort code 720000 , cash or cheque.

2. All extra costs should be paid for as soon as possible else they will be included on the monthly Statement/bill e.g. shavings, wormers, farrier etc. These should be paid as soon as incurred or within 7 days of the statement/bill.

Pennine view Stud will have a lien over property on all bills 14 days or more over due. If bills are still outstanding after 14days your horse will be put on grass livery if available until paid. If the bill is still unpaid after 1 month PVS reserve the wright to dispose of the horse in settlement for payment. If at any time you are struggling financial please talk to Pennine View Stud as early as possible to sort out an amicable solution which is best for the horse and yourselves.

3.A Full Livery includes:

- Stable
- feed up to 2 scoops a day of hard food & any other standard foods on the yard.
- Halage ad lib
- All mucking out & feeding
- Bedding - ad lib straw or 1.5 bales of shavings per week
- One Rug change - we like them to live in Turnout rugs and have a change encase very wet as this means that the horses don't get wet indoor rugs when on the walker and get more TO.
- Turning out and bring in or on and off the horse walker (once a day)
- Immediate First Aid as necessary
- No grooming except feet picking out and mud of legs, trimming and washes etc can be done by arrange ment.
- No riding - this can be arranged separately

3.B Full Livery & riding or Backing livery:

Includes ALL of full Livery plus:

Regular Grooming

Riding or lunging 5 days a week for 30 - 40 min

Additional exercise or lessons can be arranged with extra charges.

Backing livery is more as it requires 2 people for a number of weeks/sessions)

4. **5 & 2 Livery:**

- Includes DIY on Sat and sun and Bank holidays. Beds **MUST** be mucked out by 11am else PVS will muck them out for you, the standard cost will be incurred and added to the bill.

Full Livery Mon - Fri as stated below:

- All Mucking out and feeding
- One Rug change Rug see note in full livery
- Turning out and bring in or on and off the horse walker
- Immediate First Aid as necessary
- No grooming except feet picking out and mud of legs
- No riding - this can be arranged separately
- All 7 Days includes
- Halage ad lib
- feed up to 2 scoops a day of hard food & any other standard foods on the yard. ·
- Full livery can be arranged as necessary to cover holidays etc.

- Additional Costs if needed:

- T/O or BI £1.50
- Horse walker PVS to put on/take of £2
- Riding 30 min session with Lucy or a 30 min hack £20 or £20
- M/O, T/O, BI on sun or sat £8.50
- For clipping, mane pulling etc please speak to Lucy

5. It is the responsibility of the owner to have the relevant insurance for their property, horse and person whilst been kept at the yard. The yard is fully insured for our work. Any breakages/damages that are incurred by an owners horse need to be paid for or made good to Pennine View satisfaction. E.g light switches, stables, Gates etc.

6. Everyone on the yard must wear an approved BSI riding hat when mounted.

7. If any of the above information changes it is the client's responsibility to inform Pennine View Stud.

8. To terminate the contract requires a month's notice from either client or Pennine View Stud.

9. All horses and equipment left on the yard are at the owner's own risk. All equipment should be named to prevent lose/confusion. It is the owners responsibility to do so.

10. Whilst all best endeavours will be made to reduce risks to property & horses the owners and staff at Pennine View Stud can not be held responsible for any injury, damage, theft or other incident that may occur.

11. Opening Hours - the yard is open at 8am - 4pm mon to Friday and 9am - 4pm Sat and Sun. You are welcome to see your horse outside these times but please inform PVS for

the security and safety of your horse as the gates will be locked when we are not on the premises ie competing at weekends.
